European Regulation 10/2011/EC

This Regulation applies to plastic materials and articles which, in their finished state, are intended to come into direct contact with food and requires Declaration of Compliance to be made for these materials and articles. The European Regulation 10/2011/ EC as amended up to and including 202/2014/EC. The FBK master batches are furthermore in compliance with European Resolution Res AP (/89) 1.

European Regulation 1935/2004/EC



This Regulation applies to all materials and articles which, in their finished state, are intended to come into direct contact with food, together with articles and materials that can be expected to be brought into contact with food. Articles approved within this Regulation 1935/2004/EC will be marked with the Glas/Fork symbol, either directly on the product or on the hygiene package.

European Regulation 2023/2006

FBK are manufacturing articles according to EC Commission Regulation no. 2023/2006 for good manufacturing practices for material and articles intended to come into contact with food

European Regulation 178/2002

Defines traceability as the ability to trace food, feed and ingredients through all stages of production, processing and distribution, also including food safety articles.

This Regulation applies to all equipment used within the food production environment, even if it isn't used for direct contact with food. It also includes the general food safety requirement, which states that equipment used in the food manufacturing environment can't be unfit for human consumption or injurious health.
